

The Barnes County Commission met in regular session on Tuesday, March 5, 2024, with Cindy Schwehr, Vicky Lovell, Bill Carlbom, Pete Paulson, and Shawn Olauson present. Chairman Carlbom called the meeting to order at 8:00 a.m., roll-call was taken, the Pledge of Allegiance was recited, and the agenda was reviewed.

#### **Highway Department**

Jamie Smith presented three bids received for the Chip Seal project on County Rd #7. Bituminous Paving submitted a bid of \$753,175.00. Morris Sealcoat submitted a bid of \$710,101.00; Aztec submitted a bid of \$733,426. Morris Sealcoat is the lowest bid. Cindy Schwehr made a motion to accept the lowest bid contiguous upon all the numbers being correct and all the information is accurate. Shawn Olauson seconded the motion. Motion carried with all members voting "yes". DOT, Brian Tykwinski (KLJ), and Jamie are working together on the Bridge Improvement Project to bundle funding for the Peterson and Viking Bridge improvements to save money and bump up the construction date by one year.

#### **Sheriff's Office**

Randy McClaflin would like to accept the Ford Explorer bid from Stoudt Miller at \$54,422.00. This vehicle has more options on it and we already have a cage that would fit and it is a 2025 model. Cindy Schwehr made a motion to accept the Ford Explorer bid from Stoudt; Pete Paulson seconded the motion. Motion carried upon rollcall vote with all members voting "yes". Receiving bids off the lot was discussed versus fleet bids. Fleet bids do not run at the same timeline with the varying dealerships. Staffing a deputy during the Winter Show was discussed.

#### **States Attorney**

Tonya Duffy updated the commissioners on the bids and quotes received for the remodel project for the States Attorney's Office. Quotes from Ray Nelson and Dedicated Builders were received for the project. FMJ Electric LLC submitted a bid for the electrical work. Jessica Jenrich will contact the building inspector to give specs on the remodel project. Cindy Schwehr made a motion to accept the bid of \$625.00 from FMJ Electric LLC for three new outlets; Shawn Olauson seconded the motion. Motion carried upon rollcall votes with all members voting yes. Quotes were submitted for a desk with hutch and an electric sit/stand desk and desks for the front office. Tonya will also check with Valley Officeworks and Empire Furnishings. One application for Assistant States Attorney was received since the job opened in August. Tonya is proposing to start the States Attorney Assistant at \$100,000.00 to make it competitive and follow the salary and steps that is used in Stutsman County. This would make the position more attractive to prospective employees. Caseloads have been steady. The Commission will discuss the salary at the next commission meeting. Tonya updated the commissioners on upcoming training for this year. Training in Alabama in February and Rise 24 training in May in Anaheim California is paid for through grant funding. She will be attending training in April which was paid for last year. One training in March is related to Arson.

#### **Corrections**

Jeremy Wolf presented a quote of \$27,345.00 for Tasers from Axon Enterprises for a five-year term. The amount can be paid in one lump sum or \$5,469.00 per year for five years. This includes five tasers, 15 holsters, and 30 cartridges every year. Cindy Schwehr made a motion to pay \$27,345.00 with commissary funds that are included in the new equipment line item; Shawn Olauson seconded the motion. Motion carried with all members voting yes. Jeremy would like to streamline the workers schedules with a When I Work App. The app comes at a cost of \$700.00 per year. Currently, the department has it on a trial basis.

#### **Auditor – Minutes**

Bill Carlbom moved to approve the February 20, 2024 minutes; The February 20, 2024 minutes were approved with all members voting "yes". Cindy Schwehr made a motion to approve the termination contract with Tyler. Vicky Lovell seconded the motion. Motion carried with all members voting yes. All Auditors staff will be attending election training in Bismarck on March 6<sup>th</sup> and 7<sup>th</sup>. The office will be closed. The Treasurer's Office has offered to take our phone calls and clients will be directed to them. Regional training takes place on March 13<sup>th</sup> in Fargo, March 14<sup>th</sup> in Jamestown, and March 26<sup>th</sup> in Bismarck. Our staff will be able to stagger the regional training so that our office can remain open. A check was received for the East Central County Commissioners from North Dakota Unclaimed Property Division in the amount of \$3,679.77.

#### **Commission Discussion**

Pete Paulson notified the commission of the resignation of our VSO Officer Angela Hunt. Lamoure County will need to be notified. The VSO van was damaged after driving over a chunk of ice. Tammy Jacobson will run the office until a VSO Officer is hired. The van put on 1,736 miles with 28 rides. A Park Board meeting will be held once a month at 7:00 a.m. on the same day as the commission meeting. Scott Kohler will oversee the county parks. The next meeting will be March 19<sup>th</sup>. Shawn Olauson reported that a help wanted ad was posted for a half time Barnes County Water Resource District Secretary. Shawn will attend the County Summit. He may need a new laptop. He will check with Jason. Cindy Schwehr would like to officially congratulate the Valley City Hi-Liners and the Maple River Raiders basketball teams for qualifying to play in the state basketball championship. VSO staff needed permission to get into the courthouse over the weekend to pick up one of their wheelchairs. Year-end Health Insurance paperwork for tax purposes will be sent out during this week. VCPD has City County Health

District do the Law Enforcement Physicals. City of Valley City may have a measure on the ballot for flavored vaping. A PTO will be coming out of Deaconess Center in Northwood that works with kids with behavioral and sensory issues. Kally will be moving to a different position at City County Health District. They paid off their parking lot. Vicky Lovell reported on HUD having issues at the Villa with heating exchange being hot and cold. They may hire a firm to check that out. There are presently two remodels in two of their homes. Bill would like to say thank you to Alisha Harstad for the spectacular job taking over the crop show at the Winter Show. The Highway Department has past workers that would come and help part time if needed. Chili Cook-off is at 6:00 p.m. at the Winter Show tonight. He will meet with NDSU this month for evaluations.
