The Barnes County Commission met in regular session on Tuesday, April 4, 2023 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, Pete Paulson, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., roll-call was taken, the Pledge of Allegiance was recited, and the Agenda was reviewed.

Highway Dept – Excavator Bid / CDL Operator Training / Road Foreman Pay / Bike Path Design Contract Highway Superintendent Jamie Smith provided an update on equipment and personnel preparations for the impending storm. Bryan Tykwinski, Kadrmas, Lee & Jackson, provided an update on the Bike Path design. Cindy Schwehr moved to approve the design contract for the bike path; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Bill Carlblom moved to approve purchase of a 2023 Komatsu Hydraulic Excavator from General Equipment at a cost of \$214,250, with \$100,000 of the cost to be paid out of the Local Assistance and Tribal Consistency Funds (LATCF); Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Ms Smith suggested that two of their employees receive training to perform CDL training, in an effort to facilitate training of operator applicants who do not currently have CDL training. Vicky Lovell moved to increase the pay for Road Foreman Tim Tangen to \$30.50 for six months, effective next pay period, to be re-evaluated for an additional increase at that time; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Ms Smith requested to open up the Road Foreman in training position to in-house candidates; the Commission was fine with that.

Weed Board - Employee Positions

Jamen Windish, Weed Officer, suggested a change to employee positions, in an effort to attract and retain trained employees: 50/50 shared with the Highway Department, the other on a seasonal, salary basis. Shawn Olauson moved to go through with this plan; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". With this plan in place, they would only need one seasonal, part-time person. Mr Windish also provided an update on the shop project.

Auditor – Minutes / Board Appointment / NDIRF Annual Meeting / Beer & Liquor Application (Bayshore) Vicky Lovell moved to approve the March 21, 2023 minutes; Pete Paulson seconded the motion. Motion carried. Cindy Schwehr moved to appoint Amanda Olauson to fill the open District 2 Planning & Zoning Board position; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Shawn Olauson abstained from the vote. Cindy Schwehr moved to have Auditor Didier sign the proxy for the NDIRF Annual Meeting; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Cindy Schwehr moved to approve the beer & liquor applications from Bayshore Resort; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Commission Discussion

Commission discussion included portfolio updates. Theresa Will will be receiving an Outstanding Public Health Officer award at an upcoming state meeting. The Commission instructed the Auditor to advertise the Interim Auditor position, with pay depending upon experience and open until filled. Bill Carlblom has the supplies ordered for the Walking Tacos on the 18th.
