

The Barnes County Commission met in regular session on Tuesday, April 7, 2020 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, John Froelich, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Planning & Zoning – Feedlot Ordinance / Setback Violation

Jessica Jenrich, Planning & Zoning Coordinator, participated via conference call and presented proposed updates to the Animal Feeding Operation section of the Planning & Zoning code, which will go to the Planning & Zoning Board on Thursday. Ms. Jenrich asked for guidance on a landowner who placed some grain bins too close to the road without an approved Setback application.

Highway Dept – Engineering Contract

Kerry Johnson, County Highway Superintendent, presented the construction engineering contract with Interstate Engineering for the Hobart Grade Raise project for Commission signature. Cindy Schwehr moved to approve the contract; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Construction will begin June 1st, to be completed August 15th. Cindy Schwehr moved to approve the design engineering contract with Kadmas, Lee & Jackson for the Erosion Site on the Kathryn Road; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. There will be Mr. Johnson provided updates on county road status.

Auditor – Minutes / NDIRF Proxy

Shawn Olauson moved to approve the March 17, 2020 regular meeting minutes, March 18, 2020 Special Meeting minutes, and March 19, 2020 Special Meeting minutes; John Froelich seconded the motion. Motion carried. Cindy Schwehr moved to sign the NDIRF proxy; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

2020 Primary Election Changes

Due to the COVID-19 crisis, Governor Doug Burgum, in Executive Order 2020-13, ordered that the requirement under North Dakota Century Code §16.1-11.1-01, that each county identify one polling location to be open on election day, is hereby suspended. In response to this, Cindy Schwehr moved to have no in-person Election Day polling location open in Barnes County for the June 9, 2020 Primary Election; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. All voting in Barnes County for the 2020 Primary Election will be Vote-By-Mail. A drop-box for ballots will be made available on the north side of the courthouse.

Commission Discussion

Commission discussion included a proposed South Eckelson Lake fishing access and proposed outlets for 10-Mile Lake and Silver Creek.

Highway Dept – Culvert Bid Opening

Cindy Schwehr moved to approve the culvert bids from True North Steel for corrugated metal culvert per their price schedules; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Highway Dept – Road Oil Bid Opening

Cindy Schwehr moved to waive the bond requirement to provide bid bond, contingent upon the State’s Attorney’s approval; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. The bid bond was then located inside the bid. Cindy Schwehr retracted the motion; Vicky Lovell retracted the second. Cindy Schwehr moved to allow the bid, even though the bidder did not follow the instructions to provide the bid bond in a separate envelope outside the bid envelope, pending approval of the State’s Attorney; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Cindy Schwehr moved to approve the road oil bid from Flint Hills for MC3000 at \$590 per ton and CRS2P at \$470 per ton, delivered; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

COVID-19 Update

City-County Health District Director Theresa Will participated via conference call and updated the Commission on the local COVID-19 crisis response and some of the County costs, thus far.
