Meeting called to order by Chairman Mike Schwehr at 6:00 p.m.

Motion by Bishop, 2nd by S. Olauson to approve the April 9, 2024 minutes. Motion carried.

Meeting recessed for Terry Kellogg for structure setback variance of 60' from the center of the subdivision road. Mr. Kellogg was present to answer any questions from the board. No one appeared to protest. Schwehr reopened the meeting for discussion. Motion by Bishop, seconded by A. Olauson to approve the Variance and advised Mr. Kellogg to check into soil boring to make sure land is stable where he wants to place building. Motion carried.

Meeting recessed for Joel Iverson for a structure setback variance of 132' from the center of county road 20. Mr. and Mrs. Iverson were present to answer any questions from the board.
