

The Barnes County Commission met in regular session on Tuesday, June 2, 2020 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, John Froelich, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

**Safety Committee – Safety Bucket Funding**

Debbie Magnuson, Barnes County Employee Safety Committee member, requested additional funding for the safety buckets to cover the amount not covered by the grant funding received. The commission agreed that they should go ahead and finish the project.

**Corrections – Equipment Request**

Jeremy Wolff, Chief Correctional Officer, requested two extraction suits at a cost of \$530 each and one Redman training suit at a cost of \$1,837 from Galls. John Froelich moved to approve the request; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**Highway Department – Approach Applications / Emergency Repair Quotes & Discussion**

Kerry Johnson, County Highway Superintendent, presented Approach Applications from Chad Wendel and Otter Tail Power Company for approaches in 17-140-59. Bill Carlblom moved to approve the applications; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Work has begun on the Hobart Lake Grade Raise. Quotes were received from Strata in the amount of \$181,473 and from Scherbenske’s in the amount of \$202,426 for the Meadow Lake Erosion Repair project on County Road #7. Strata will be doing the work. County Road #11 south of Sanborn is eligible for an emergency grade raise. Matt Lange, Kadmas, Lee & Jackson, updated the Commission of ER work. Next year, will complete the permanent grade raise at a 20% local cost share. Cindy Schwehr moved to go forward with the Emergency Work and to pursue quotes, run them by the portfolio holders and move forward; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Quotes to add a 12’ bypass lane at the Kathryn road erosion site on the river were received from Border States in the amount of \$85,314 and from Strata in the amount of \$122,049; the quote from Border States was accepted. Kathryn hill-slide repair project is moving forward. Culvert replacement near Kathryn on County Road #21 South will be completed yet this month. at Kathryn Star to do yet this month. Garret Suhr has been hired, to start June 15<sup>th</sup>.

**State’s Attorney – Employee Reviews & Raises**

Tonya Duffy, State’s Attorney, informed the Commission that Katie Nechiporenko and Beverly Vernig have both successfully graduated from trial-period status, and requested that they receive pay increases (\$31.56 to \$33.56 and \$17.17 to \$18, respectively). Cindy Schwehr moved to pay Ms. Nechiporenko \$32.81; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Cindy Schwehr moved to pay Ms. Vernig \$17.76; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**Auditor – Minutes / Gaming Site Authorization – Sodbusters Saloon**

John Froelich moved to approve the May 19, 2020 minutes; Shawn Olauson seconded the motion. Motion carried. Cindy Schwehr moved to approve the Gaming Site Authorization for Cooperstown Municipal Association for a site at Sodbusters Saloon in Sibley; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**Commission Discussion**

Commission discussion included Veterans Service, Airport, Election, sidewalk repairs, and opening up the Courthouse. The Commission agreed to open the Courthouse to the public on Monday, June 15<sup>th</sup>.

Tax Director Stacie Hansen-Leier presented updated information for the afternoon’s Equalization meeting.
