

The Barnes County Commission met in regular session on Tuesday, June 4, 2019 with Cindy Schwehr, Vicky Lovell, Bill Carblom, John Froelich, and Shawn Olauson present. Chairman Carblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

US Fish & Wildlife – Purchase of Property

Kurt Tompkins and Doug Mosser, US Fish & Wildlife Service, presented a proposed land acquisition by the US Fish & Wildlife Service in Barnes County, namely the S ½ S ½ 29-141-57 (160 acres) from Bruce and Bonnie Ranum. Bill Carblom moved to approve the proposal; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

City-County Health – ROPES Harm Reduction Project

Theresa Will, City-County Health District Director, along with project partners, presented information on the ROPES Project. The Rural Opioid Prevention Education and Support (ROPES) project is a federally and locally funded grant program using evidence-based practices to better serve people affected by Substance Use Disorder (SUD) and the disease of addiction. John Froelich moved to support this program; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Policy Manual Updates

Jamie Smith, Barnes County Employee Policy Committee Chair, presented the proposed changes to the policy for Commission review. John Froelich moved that essential personnel who were required to work will be paid time and a half for the amount of hours that the Courthouse was closed and that 12:00 am is the start of a new day; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Vicky Lovell moved to approve the other recommended changes, as amended by the Commission; Bill Carblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Highway Department – Approach Application / Engineering Contract / Road Updates

Cindy Schwehr moved to approve the Engineering Contract with Kadrmas, Lee & Jackson, estimated at a cost of \$149,700 maximum contract, for this summer’s road projects; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Kerry Johnson, Highway Superintendent, presented an Approach Application from Don Schlotman on behalf of Faith Lutheran Cemetery Board at 20-140-59. John Froelich moved to approve the application; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Kerry Johnson, Highway Superintendent, provided update on the roads and projects. A pipe at the lift station at the viaduct on County Road #22 failed and a liner was installed. Vicky Lovell moved to open County Road #22 at Hobart Lake with reduced speed limit signage; John Froelich seconded the motion. Motion carried upon roll-call vote, with Cindy Schwehr and Bill Carblom voting “no”.

Auditor – Minutes

John Froelich moved to approve the May 21, 2019 minutes; Shawn Olauson seconded the motion. Motion carried.

Sheriff – Online Time Sheets

Randy McClafin, Sheriff, requested permission to have his staff log time worked on a phone app. We currently do not have software that has this functionality. Bill Carblom moved that the County allow punching in on their PCs, rather than the time clock, if they so choose; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. The computer in Jed Reile’s car went out and they would like to replace it sometime in the future with a different PC at an approximate cost of \$5,000 to \$6,000.

Tax Equalization –Equalization Briefing

Stacie Hansen-Leier, Tax Director, briefed the Commission on the upcoming equalization proceedings and provided some updated handouts.

Special Event Permit – Hill Climb

Cindy Schwehr moved to approve an Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises from Boomer’s for the Dakota Rider’s Hillclimb on June 16, 2019; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Commission Discussion

John Froelich provided an update on the Social Services Redesign and Zoning project. The estimate for the new radios came in at approximately \$290,000, rather than \$250,000. Shawn Olauson provided an update on Water Resources Silver Creek issue. Cindy Schwehr said west end Devils Lake is running. Jail Request for Qualifications has been sent for advertising.

Vicky Lovell moved to recess for lunch; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.
