

The Barnes County Commission met in regular session on Tuesday, July 5, 2022 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, Pete Paulson, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:00 a.m., roll-call was taken, the Pledge of Allegiance was recited, and the Agenda was reviewed.

**Dispatch/Corrections/Sheriff – CAD System**

Holly Neuberger and Sarah Miller, Dispatch, appeared to continue discussion regarding the request for a new CAD system. The Commission asked for monthly updates on the current system.

**NDWS – Budget Request**

Brandee Moore, North Dakota Winter Show Manager, tuned in via TEAMS meeting and presented the 2023 NDWS budget request.

**Auditor – Minutes / Prisoner Boarding Contract / Credit Card**

Vicky Lovell moved to approve the June 21, 2022 minutes; Shawn Olauson seconded the motion. Motion carried. Cindy Schwehr moved to approve the Contract for Prisoner Boarding with the City of Valley City; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Cindy Schwehr moved to change credit cards from the current ELAN card to the new Dacotah Bank credit card; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**NDACo Conference - Delegate**

Cindy Schwehr moved to appoint Stacie Hansen-Leier to serve as North Dakota Association of Counties delegate at conference this year; Vicky Lovell seconded the motion. Motion carried upon roll call vote, with all members voting “yes”.

**Jail – Noise Reduction Panels**

Cindy Schwehr moved to approve purchase and installation of sound-absorbing panels from Fargo Glass and Paint Co at a cost of \$4,765.00; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

**Commission Discussion / Kathryn City Request**

Commission discussion included portfolio reports.

Cindy Schwehr moved to give the City of Kathryn \$17,879.59 from the State and Local Fiscal Recovery Funds (SLFRF) for a pump and that cities be encouraged to work together to address pump needs in the future, as feasible; Vicky Lovell seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.
