

The Barnes County Commission met in regular session on Thursday, July 6, 2023 with Cindy Schwehr, Vicky Lovell, Bill Carlblom, Pete Paulson, and Shawn Olauson present. Chairman Carlblom called the meeting to order at 8:02 a.m., roll-call was taken, the Pledge of Allegiance was recited, and the Agenda was reviewed.

Dispatch – Quality Assurance & DOR Tracking Program

Sarah Miller, Dispatch Coordinator, presented some quotes for quality assurance, training and motivation programming and requested to go with Frontline at a cost of up to \$1,916.00 through the remainder of this year and \$3,612.50 annually. Vicky Lovell moved to approve the request; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

MIS – Courthouse Cameras

Jason Thiel, MIS Director, presented a proposal from Electro Watchman, Inc. to install and set up camera equipment to cover areas currently not covered and to switch power to the existing cameras, at a cost of \$22,621.14 plus \$575.00 for the power. Cindy Schwehr moved to approve the request to be paid out of State & Local Fiscal Recovery Funds; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Auditor – Minutes

Pete Paulson moved to approve the June 20, 2023 minutes; Shawn Olauson seconded the motion. Motion carried.

Board Appointments

Vicky Lovell moved to make the following board appointments: Housing Authority – Kenneth Beach; and School Annexation, Reorganization, and Dissolution Committee (District 1) – Mike Schwehr; Shawn Olauson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Interim Auditor Appointment

Shawn Olauson moved to appoint Julie Mindt to serve as Interim Auditor, to fill the unexpired term of Barnes County Auditor Beth Didier, whose resignation will take effect at close of business on November 8, 2023, at which time Ms Mindt will officially become the Interim Auditor, with Ms Mindt to be paid, effective next pay period, an in-training wage of \$34.00 per hour, to be reviewed in six months; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.
