

The Barnes County Commission met in regular session on Tuesday, September 4, 2018 with Cindy Schwehr, Mike Metcalf, Bill Carblom, John Froelich, and Rodger Berntson present. Chairman Carblom called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Building & Grounds – Roof Replacement

Stan Horst, Building & Grounds, along with Joe Malloy, TectaAmerica, presented quotes to replace the roof ranging from \$81,698 at the current R-Value for the lower section only to \$113,753 for the entire roof, including additional R-Value. Mike Metcalf moved to approve the entire roof replacement project at a cost of \$113,753; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Resolution #2018-3 Providing for the Sale of \$500,000 Limited Tax Bonds

Mike Metcalf moved to approve Resolution #2018-3, outlined below; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

RESOLUTION #2018-3 PROVIDING FOR THE SALE OF \$500,000 LIMITED TAX BONDS, SERIES 2018

BE IT RESOLVED by the Board of County Commissioners of Barnes County, North Dakota (the "County"), as follows:

Section 1. Authorization. The County is authorized pursuant to North Dakota Century Code Chapter 57-47 (the "Act") to finance primary governmental functions under the terms and conditions set forth in the Act. The County intends to issue bonds in order to provide funds to construct, enlarge or repair bridges and to pay costs of incidental to such construction, enlargement or repair and bond issuance.

Section 2. Sale. Pursuant to the provisions of the Act, the County shall proceed to offer at negotiated sale its Limited Tax Bonds, Series 2018, in the principal amount of \$500,000 (the "Bonds"). The governing body shall meet at a subsequent date to consider the bid and take such action regarding the Bonds as shall then be deemed necessary and expeditious.

Section 3. Official Statement. The County Auditor, in cooperation with Dougherty & Company LLC, underwriter to the County, is authorized and directed to prepare on behalf of the County an official statement to be distributed to potential purchasers of the Bonds. Such official statement shall contain such official notice of bond sale and such other information as shall be deemed advisable and necessary to adequately describe the County and the security, terms and conditions of the Bonds. Such official statement shall be examined and approved by the County Auditor prior to its distribution to potential purchasers.

Wanda Larson and Dana Lindemann appeared before the commission to express concerns about losing employees to neighboring counties, and Ms. Larson requested permission to try on-call comp time on a trial basis for a month. Mike Metcalf moved to approve a three-month trial period for on-call comp time (one hour of comp

time for each day they are on call, which must be used by the end of each month) for Social Services employees who must be on call; John Froelich seconded the motion. Motion carried upon roll-call vote, with Rodger Berntson and Cindy Schwehr voting “no”.
