Motion by Bishop, 2<sup>nd</sup> by Carlblom to approve October 8, 2020 minutes. Motion carried.

The board requested that Trevor Jacobsen and Jay Praska be at the meeting so that they could discuss the grain bin issue in person and over phone with them. Jay is from NDDOT Valley City District and was present over the phone to discuss the timeline with this and provided a draft of the agreement that will be sent out to the landowner to sign between NDDOT and the land owner.
